

**NOTICE OF ADOPTION
ORDINANCE # 2025-008**

**AN ORDINANCE AMENDING THE TOWN OF WAYNETOWN, INDIANA
CODE OF ORDINANCES, TITLE V, PUBLIC WORKS
CHAPTER 52 SEWERS**

WHEREAS, currently the Waynetown Wastewater (Sewer) utility imposes connection impact fees depending on the size of the water meter, with five (5) different rates ranging from 5/8 inch meters (\$500) to 2 inch meters (\$5,000);

WHEREAS, for administrative simplicity and to better reflect the impact of new connections on its municipal sewer system, the Town Council of Waynetown, Indiana, as both the legislative body and utility service board of the Town, has determined that the existing fee structure should be simplified, with only one connection fee to be imposed, regardless of the size of the water meter.

NOW THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WAYNETOWN, INDIANA, AS FOLLOWS:

Section One. Chapter 52.08 of the Town's Sewer Utility Rates and Charges is hereby amended to replace and wholly supersede the current provision with the following:

52.08 Each user connecting to the town's sewage works shall pay a fee upon connection, to be designated as the impact fee, in the amount of \$1,500.

Section Two. All rates and charges not amended by this ordinance shall remain in full force and effect.

Section Three. Miscellaneous Provisions.

(a) The findings and determinations set forth in the preambles to this ordinance are hereby made findings and determinations of the Council.

(b) The provisions of all prior ordinances inconsistent with any of the provisions contained in this ordinance are hereby repealed.

(c) The subsequent invalidity of any section, clause, sentence, or provision of this ordinance shall not affect the validity of any other part of this ordinance which can be given effect without such invalid part or parts.

(d) This ordinance shall be effective thirty (30) days after publication.
