

**NOTICE OF ADOPTION
ORDINANCE NO. 2026-002**

**AN ORDINANCE AMENDING CHAPTER 70.01 UNLAWFUL OPERATION AND 70.99 PENALTIES
OF THE TOWN CODE FOR THE TOWN OF WAYNETOWN, INDIANA**

THEREFORE BE IT HEREBY ESTABLISHED AND ORDAINED by the Town Council of the Town of Waynetown, Indiana that:

Section 1: Chapter 70.01 of the Town Code of Waynetown, Indiana, concerning unlawful operation of certain vehicles, is hereby amended to now read as follows:

70.01. UNLAWFUL OPERATION

(A) It shall be unlawful for any person to operate a dirtbike on the streets, alleys, sidewalks or other public place within the Town of Waynetown unless that vehicle is being used as a personal mobility device as such a device is defined by the Federal Americans with Disabilities Act.

(B) It is now lawful for any person to operate an all-terrain vehicle (ATV) or 4-wheeler on the streets or alleys, (but not sidewalks) or other public place within the Town of Waynetown, as long as the operator is at least 16 years of age with a valid Indiana Operators License, proper registration through the Indiana Bureau of Motor Vehicles (if required), registered with the Department of Natural Resources and current on all registrations, have a current Department of Natural Resources sticker affixed to the left front of the vehicle.

(C) It is now lawful for any person to operate a snowmobile on the streets or alleys, (but not sidewalks) or other public place within the Town of Waynetown as long as there is at least three inches of snow located on the majority of the ground. For legal operation on the streets and alleys, the street and alleys must be snow covered. The snowmobile must be registered with the Department of Natural Resources and have a current Department of Natural Resources sticker affixed to the left front of the snowmobile.

(D) All vehicles operated on the streets or alleys must have proper insurance as required by the State of Indiana.

Section 2: Any person violating 70.01 shall, upon conviction thereof, be fined per Town Code Chapter 70.99.

Section 3: 70.99 Section (B) fine schedule is amended from; Any person violating 70.01 shall, upon conviction thereof, be fined \$25 if the conviction is that person's first offense to \$100 for the person's first offense, and fined \$50 if the conviction is that person's second or subsequent offense under 70.01 to \$250 if that conviction is that person's second or subsequent offense under 70.01.

Section 4: (a) This Ordinance shall be in full force and effect upon adoption and time requirement under State of Indiana Law.

(b) All ordinances or parts of Ordinances in conflict here with are hereby repealed concurrent with the effective date set forth in this Ordinance.
